#### Auditor General's report

#### Audit opinion - Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use
  of resources.

#### **Basis for Qualification**

#### **Accounting Statement**

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position for the year:

There are a number of discrepancies related to staff costs between the relevant payslips and actual payments made.
the payments made being less than that recorded on the payslips. My audit also identified payslips that could not be
matched to a payment. Therefore, I am unable to conclude on the completeness and accuracy of the accounting
records.

#### **Annual Governance Statement**

In my opinion, the Annual Governance Statement is not consistent with the Council's arrangements in the year:

- The Council does not publish information it is required to publish on its website by the Local Government (Democracy)
  (Wales) Act 2015. Specifically, it has not published the Auditor General's report on the 2018-19 accounts and unaudited
  accounts for 2019-20, 2020-21 and 2021-22.
- The Council has not maintained proper accounting records as required by the Accounts and Audit (Wales) Regulations 2014.
- The Annual Governance statement is not consistent with the findings set out in the Internal Auditor's report.
